GENERAL SUMMARY

File No. 13941

August 26, 1946.

Re: Toyokazu NISHIHAMA, Reg. No. 09666

This man did not sign a declaration to the Custodian until October 28, 1943. He had been evacuated on February 24, 1942.

In his declaration he reported a carton of 16 m.m. moving picture films left at 202 Carroll St., Vancouver. On investigating some two years after this man had left, we were informed by the tenants that no chattels of any description remained at that address. *See letter Feb. 14/44*

The account of this man was credited with the sum of \$29.85 received as refund of Income Tax for 1941. This amount is being remitted to him today.

This file reveals no other property of any kind.

Mankichi NISHIHAMA filed a claim against "T. NISHIHAMA" of Britannia, B.C. We referred this to Toyokazu NISHIHAMA several times but received no reply. We so informed the creditor, Mankichi NISHIHAMA, inquiring if this claim was still unpaid, but received no reply. We are therefore taking no further action.

This file reveals no other liabilities of any kind.
