There is no evidence that this man had any interest in the boat "K.M." NW.273, NW.070-C. or J.N.673.

The license was issued to K. MIYAGAWA, Steveston, in the year 1922. Kiichiro MIYAGAWA would then be 13 years old, which makes it very improbable that he could be the K. MIYAGAWA in question.

The naval identification number was issued to Sanji MIYAGAWA, as owner. Sanji MIYAGAWA's father, Kamehkichi, is a resident of Japan.

Mitsuzo KOKOBO (Internee) has claimed the boat.

The question of ownership has been referred to the Enemy Section.

A boat was sold for \$324.00 less expenses and proceeds credited to Kiachiro MIYAGAWA, Evacues File No. 13962.

that sales proceeds should forthwith be transferred from Evecuee Account No. 13962 in the same of Kilchiro MIYAGAWA to the Enemy Section and should thereafter be credited by you althor to the account of Mitsuse KOKUBO, Intermee File No. 810, or to an account you may be opening in the name of Kamekichi MATIGAWA, a resident of Japan, depending upon your judgment of the matter following further questioning of your Internes.

In Affidavit dated April 16, 1942, Mitsuzo KOKUBO stated that he purchased the vessel in question in 1922. Mr. Mitsuso KOKUBO was born in 1922 and it is hardly likely that he conducted business at such an early age.

K. MIYAKAWA. Mitsuse KOKUBO declares that he purchased the boat from a

This vessel is licensed in the name of K. Mayagawa, Steveston.

Kilchiro MIYAGAWA, File #13962, does not declare any property.

Mitsuse KOKUEO, Internee File 810, has declared:

"I purchased this boat from a K. Maikawa, of Steveston, in the Province of British Columbia in the year 1922.

That this bost, is operating under License Number NW. 273.

That I did not receive a Bill of Sale for this boat at the time of purchase and an unable to get same at the present time, as the wheremouts of the said K. Malkawa is unknown.

That this man's name is spelled wrongly and should be K. Miyakawa and not K. Mayagawa as noted on License."

The Internee has, apparently, been unable to furnish the full name of the previous owner (which is understandable when you consider that, according to the record, he purex chased this boat when he was less than one year old).

I think the monies received for this boat should be held until K. Miyakawa turns up here, or in Japan.

X The man referred to in the attached file was born in 1909, which would make him 12 years old when he sold the boat,

I have written the Dept. of Fisheries asking about fishing license number 673. Which appeared on the boat.
