MEMORANDUM TO FILE 13962

Jan. 21, 1944

Re: Kiichiro MIYAGAWA, Reg. 03537

There is no evidence that this man had any interest in the boat "K.M." NW.273, NW.070-C. or J.N.673.

The license was issued to K. MIYAGAWA, Steveston, in the year 1922. Kiichiro MIYAGAWA would then be 13 years old, which makes it very improbable that he could be the K. MIYAGAWA in question.

The naval identification number was issued to Sanji MIYAGAWA, as owner. Sanji MIYAGAWA's father, Kamehichi, is a resident of Japan.

Mitsuzo KOKOBO (Internee) has claimed the boat.

The question of ownership has been referred to the Enemy Section.

MEMORANDUM - MR. WRIGHT

Attached is your file No. 810 covering Internee Mitsuzo
KOKUBO.

A boat was sold for \$324.00 less expenses and proceeds
credited to Kiichiro MIYAGAWA, Evacuee File No. 13962.

From a study of Enemy File No. 810, I am of the opinion
that sales proceeds should forthwith be transferred from Evacuee Account
No. 13962 in the name of Kiichiro MIYAGAWA to the Enemy Section and should
thereafter be credited by you either to the account of Mitsuzo KOKUBO,
Internee File No. 810, or to an account you may be opening in the name of
Kanekichi MAYEGAWA, a resident of Japan, depending upon your judgment of
the matter following further questioning of your Internee.

In Affidavit dated April 16, 1942, Mitsuzo KOKUBO stated
that he purchased the vessel in question in 1922. Mr. Mitsuzo KOKUBO was
born in 1922 and it is hardly likely that he conducted business at such
an early age.

Mitsuzo KOKUBO declares that he purchased the boat from a
K. MIYAKAWA.

Re: Fishing Vessel "K. M.", NW 273, or "J.N. 673"

This vessel is licensed in the name of K. Mayagawa, Steveston.
Kiichiro MIYAGAWA, File #13962, does not declare any property.

Mitsuo KOKUBO, Internee File 810, has declared:

"I purchased this boat from a K. Maikawa, of Steveston, in
the Province of British Columbia in the year 1922.

That this boat, is operating under License Number NW.273.

That I did not receive a Bill of Sale for this boat at the
time of purchase and am unable to get same at the present
time, as the whereabouts of the said K. Maikawa is unknown.

That this man's name is spelled wrongly and should be K.
Miyakawa and not K. Mayagawa as noted on License."

The Internee has, apparently, been unable to furnish the
full name of the previous owner (which is understandable
when you consider that, according to the record, he pur-
chased this boat when he was less than one year old).

I think the monies received for this boat should be held
until K. Miyakawa turns up here, or in Japan.

X The man referred to in the attached file was born in 1909,
which would make him 12 years old when he sold the boat,

I have written the Dept. of Fisheries asking about fishing
license number 673, which appeared on the boat.
