With reference to your claim of \$153.92 which you lodged with the Custodian some considerable time ago against the above named. We wrote to URANO on several occasions and have ultimately received a reply through the B. C. Security Commission, which reads as follows:-

"Regarding your letter of May 8th you have stated that we owe \$153.92. I have nothing to do with it. Mr. Hideo Nakai took my signature and he signed for it. There is a statement in which it states that at Canadian Industries Ltd. Hideo Nakai is somewhere in the East. "Please send us the money as soon as possible."

We would like to have your comments on URANO'S letter - especially on the last sentence of the first paragraph, where he seems to insinuate you are aware that the claim is against Hideo NAKAI and not against him.

We would also be glad to have a detailed statement as to what your claim represents.
