

If you have no property remaining in the Protested Area, please fill up, sign, have witnessed and return to us the enclosed "No Property" declaration card.

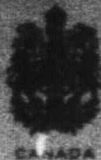
