In reviewing your file and that of your father, recently deceased, we find that there are some claims lodged against him with the address given as 332 Heatley Ave., Vancouver, B.C. As the property at this location is being dealt with in your name, it would seem that you might be interested in the payment of these claims.

At the time of the purchase of the property in your name from the City of Vancouver, December 1st, 1937, you were apparently about 20 years of age, and no doubt your father was in control and handled the business of looking after the rooming-house.

Your file indicates that you were, at some period, a millhand at the B.C. Pulp and Paper Co. Ltd., Wood-fibre, B.C.

We shall be obliged if you will let us hear from you regarding these claims, particulars of which we can give you, and if we may regard you as liable for the payment of them.
