GENERAL SUMMARY

RE: Kiyomitsu KAWASAKI, Reg. No. 10281

He was evacuated on March 10/42. We sent J.P. forms for him to fill in and return but he failed to comply with our request. On Jan. 10/44 we sent him a "No property" card to complete and return, but his wife filled it out, signed it, and returned it to this office.

On March 8/43 he signed an application for refund of 1½ wage deductions for first six months of 1941. He was formerly employed as a journalist at the Fairiku Nippo Sha. This refund in the sum of \$4.80 was received in this office and credited to the account of KAWASAKI. This is his only credit with the Custodian.


There are no claims on file against him. There are no claims on the file of his wife.

No property interests other than those mentioned above are found on this file.

The above summary is certified to be in accordance with the information on file.
