Life Insurance: Although not declared, this file reveals a Sun Life Assurance Policy, No. 2264789, in the name of the above Evacuee. This Policy did not come under the control of the Custodian's Office.

A letter on file dated October 26, 1943 from the Sun Life Assurance Company revealed that the above Evacuee has a Supplementary Contract of Deposit #2265085 with them under which interest is payable annually on November 1st and at the above date they stated they held \$35.00 payable to the above as at November 1, 1943. We gave the above Company authority, by letter dated November 2, 1943, to forward these interest payments annually. Accordingly the above amount of \$35.00 was sent to the Evacuee through this office on November 15, 1943 and November 2, 1944, respectively. In June 1945 the above Evacuee requested from the Sun Life \$200.00 on this Contract, same representing withdrawal of part of the Principal amount on deposit; this cheque was sent to us by the Sun Life, which we in turn forwarded to Mr. Ando on June 19, 1945.

No further action regarding this policy has been taken by this office.
