It is noted that you have made an error in arriving at the amount forwarded, namely \$6.34, as this is 50¢ too much. In subtracting \$16.65 from \$22.49 you make it \$6.34, whereas it should be \$5.84 a difference of 50¢, which remains to the credit of Tomio NOSE, File No. 8583.
