As requested in your letter of March 11th, 1946, we enclose herewith Custodian cheque in the sum of \$50.00. As this is your total credit balance with this office we are closing your file.

When you made your declaration to the Custodian on August 29th, 1943, you stated that you owned no chattels whatsoever in any protected area of British Columbia.

According to information supplied to this office you were the registered owner of a fishing vessel the "E.I. 1185", which was sold through the Japanese Fishing Vessel Disposal Committee for the net sum of \$1,089.00, and this sum was paid to you on March 20th, 1942.

You declared a life insurance policy No. 2198979 with the Sun Life Assurance Company of Canada, in your own possession. This did not come under the control of the Custodian.

It would appear that we have accounted for all the property of every kind left by you in the protected area which vested in the Custodian, and in order that you may confirm this and acknowledge the cheque, we are enclosing a stamped addressed envelope for convenience in replying.



This has reference to your inquiry regarding the nets belonging to Kunagoro ISHIBASHI left with Stan Leslie at 118 Moncton Street, Steveston, B.C.

In a telephone conversation with Mr. Leslie on March 28th, he states Kunagoro ISHIBASHI did leave one sockeye net with him and also a small piece of net of no value. In connection with the price paid for the sockeye net, Mr. Leslie claims our agent at Steveston, Mr. Robinson, set the figure at \$50.00. At the same time, Mr. Robinson took away the piece of net, mentioned above, for which he gave a receipt. This can be produced upon request.

As for the size of the net mentioned by Mr. Robinson, namely 5x50x60F, Mr. Leslie states that the actual size of this net is 5x55 and he cannot remember the actual fathom length. He is of the opinion, however, that Mr. Robinson estimated the fathom length of this net as it was rolled up and left in Leslie's cellar, and thus it would be quite possible to make a mistake of 20 fathoms, more or less.

In a telephone conversation of March 28th with Mr. Robinson, he could not remember whether this net was appraised by Mr. Leckie or not. His usual procedure would be, if Mr. Leckie was not available, to have a net boss in one of the Canneries appraise it.
