This man was evacuated on May 31, 1942. A declaration to the Custodian, dated July 27, 1943, is on his file, but it carries instead of a signature a pencilled notation "will not sign."

Under date of May 5, 1943, is a copy of letter from the British Columbia Security Commission to Richmond Transfer asking that a sewing machine, a box of dishes, 2 men's suits and a box of books be picked up at 524 West 12th Avenue, Vancouver, the home of Mr. Campbell, and shipped to this Japanese at New Denver, at the Commission's expense.

Camera:

The camera described in Specified Articles Memorandum was seized by the Royal Canadian Mounted Police, at New Denver, on March 30, 1943, after this man's permit to take pictures was revoked.

Woney Refund of 1 per cent wage deductions for first six months Owing of 1941 received from the Provincial Collector, Vancouver, to Him: in the amount of \$4.68, was credited to this man's account.


