We are in receipt of your letter of the 2nd instant and would advise that this Evacuee declared no real property or chattels. In his JP form dated August 2nd, 1943 he stated he had about \$300.00 in the Royal Bank of Canada, Harpole Branch, Vancouver, B. C., and that he had a \$1500.00 life insurance policy with the London and Scottish Assurance Company. Later information on our file discloses that the policy number is 128564, the premium being \$69.00, payable annually.

Beyond the above information there is nothing on our file relating to this Evacuee.

We note that this Evacuee, wife of the above, is a patient in Rosendale Mental Hospital, and we would advise that according to the information on our file no assets whatsoever were declared by Mrs. Nakabayashi.
