

Mr. MacLennan, Barrister & Solicitor, acting on behalf of B.C. Purchasers Co-Operative Association, which Association lodged the above claim against Mr. Kojima, was advised of the information received from these Evacuees and we suggested that he contact Mr. Kojima direct as this office held no funds belonging to this Japanese person.
