In his Statement of Assets and Liabilties, he declared no assets and no liabilities. The sum of 514 was received from the Department of Mines and Resources, being payment of wages owing to FUJIMOTO. This sum was remitted to Angler Internment Camp to be placed in the canteen fund of FUJIMOTO. In July 1945 his account was credited with the sum of 20%. His wife has a credit of \$42.64 with this office. Bather than send him a chaque for such a small sum, we have transferred the credit of 20¢ to the account of his wife, and the entire sum of \$42.84 is being sent to her at once. A claim in the sum of \$9.00 was fixed against FUJIMOTO by Dr. UCHIDA, but this account was withdrawn by Dr. UCHIDA.
