



This file reveals that KOYAMA owned no real property in any protected area of B.C. and did not carry any fire insurance.

CHATELS: KOYAMA, made his declaration to the Custodian on August 22/43 and was evacuated on March 15/42. He declared no property of any kind whatsoever.

SPECIFIED ARTICLES: On March 17/42 Yukio UYSEGI surrendered to the R.C.M.P. on behalf of Gisaburo KOYAMA, a Marconi combination radio. This was handed over to the Custodian on Dec. 17/43 and sold at auction for the net sum of \$32.38 and this sum credited to the account of KOYAMA with this office.


