GENERAL SUMMARY

RE: Ryotaro EBISU, Reg. No. 05070

The above who made his declaration to the Custodian on Sept. 6/42 and was evacuated on March 20/42, declared the same effects as his wife, Koito, and these have been administered on her file No. 4539.

On July 10/46 the above sent us, through the Department of Labour, Japanese Division, a Custodian release for a sewing machine, stated to be stored at Mio Sanjin Kai, 3rd Ave. & Moncton St., Steveston. We advised the Dept. of Labour as per our letter of the 19th instant that neither the above nor his wife had declared a sewing machine and that we had no record of finding a sewing machine that could be identified as belonging to the above among the goods removed by the Custodian from that address.

There are no claims on file.

The above summary is certified to be in accordance with the information on file.
