

CHATELS:

The above, who made her declaration to the Custodian on Sept. 21/43, declared some household effects stored at the house of Jiroichi TANAKA, Chatham St. and 6th Ave., Steveston, B.C.

The file reveals that this house was completely destroyed by fire on Dec. 21/44.

A letter dated Jan. 18/45, from Mrs. A. Hubert, who was the tenant of this house, states that about two years previously when her husband was away, she had put the heaviest things out in the shed and the agent of the Custodian was asked to come and take them away. A memo of Feb. 10/45 from Mr. H.F. Green deals fully with the situation which was created.

We wrote the above on April 11/46 advising her of the fire which destroyed all the contents of the house at that time.

The file reveals the above did not own any specified articles.

No property interests other than those mentioned above are found on this file.

Jiroichi TANAKA declared no chattels in the protected area on April 15, 1942. Mr. Mather, Custodian's agent, in his report of July 31, 1942, inventories chattels. Later, it was discovered from declarations that Mitsui TANAKA, a son (file #9027), Mrs. Yama MATSUMI (file #14828) and Hirokichi MORIYA (file #4985) had declared they stored chattels at TANAKA's home - 33 Chatham Street, Steveston, B.C. Mr. Tanaka confirms on October 30, 1944, a list of chattels submitted by MORIYA which was claimed to be stored at TANAKA's house.

On August 14, 1942, Mr. King, Custodian's agent, sent in a signed list from the tenant, Arthur Hubert, which was identical to the list submitted by Mr. Mather.

On November 4, 1944, Mr. Harris, Custodian's agent, was requested to remove the chattels from this house and on November 16, 1944, under the name of MORIYA he removed six items to #3 warehouse at Steveston. This list was placed on MORIYA's file. In a follow-up memorandum of November 22, 1944, from Mr. Harris, he states the tenant Mrs. Hubert claims she went out of town sometime ago and had arranged with C.C. Robinson to pick up certain chattels and that he had made another list. Mr. Harris checked this with Mr. Robinson and this could not be remembered by him. Mrs. Hubert also claimed certain chattels were sold by Mr. Robinson. However, appearing on the file is a new inventory with no date, signed by Mrs. Hubert which shows a considerable shrinkage of articles from the list of goods she originally signed for in August 1942. Also on the file appears in Mr. Green's (of the Custodian office) hand-writing, the remarks that one davenport and one dining room table was held by the neighbors. These items appear in the inventory signed by Hubert and it must be assumed that Robinson did go in and remove certain articles and loaned these two items to the neighbors. On the removal of goods by Harris in November 1944, he abandoned as valueless 3 bed springs and one home-made table.

On December 24, 1944, this house was completely destroyed by fire. There was insurance coverage in the amount of \$300.00 on the contents. No direct investigation appears to be made by the Custodian's Insurance Department but the firm of J.M. Robinson Company, adjusters, received a statement from Mrs. Hubert dated January 18, 1945, in which she claims she had placed chattels in the shed at the rear for Mr. Robinson of the Custodian to pick up, and then she was absent from the premises from Easter until August, and on her return, found only a few old bedsteads and a box that had been broken into by her children during her absence. She also states that before Christmas another man came with a list (this we think means Mr. Harris when he removed the goods in November under MORIYA's name). He took the stove that was in the shed and a few other things, chairs, and the only thing they left was a home-made kitchen table and a long bench. The bureau was out in the shed but the children had broken the mirror. Owing to the above statement by the tenant, no insurance could be collected on the policy which covered the furniture. The dining room table held by the neighbor whose name appears to be Reid was sold by Mr. Harris in the amount of \$3.00. This was credited to TANAKA's account but later transferred to MORIYA. The davenport was never recovered, as it appears this party has left the locality. As formerly stated, no chattels were declared and no chattels credited to TANAKA's account. The chattels of the individual Japanese, left in TANAKA's home, will be dealt with on their respective files.

RE: Chattels at 33 Chatham St., Steveston.

As Mr. MacCallie says in his memo of December 12th, 1944, searched for files 4120 and 4985, but only appearing on the latter file, the position here is unsatisfactory. The following will endeavour to summarize the transactions as a preliminary to further action.

File 4120 - J. J. MERRILL. No chattels were declared but a reference is made in records "All furniture in brother's name". I cannot trace the brother, but from what is written below this information is not relevant.

An inventory of the effects at this house, 33 Chatham Street, Steveston, is attached to the investigating agent's report of July 31st, 1942, real property section of the file. The house was rented to Mr. Hubert on Aug. 4th, 1942, as per Mr. King's letter of August 15th, at which time an inventory signed by Mr. Hubert was sent to us. Mr. King considered that these effects did belong to J.T., and mentioned that the house had been broken into between the evacuation of J.T. and occupation by Mr. Hubert. The list signed by the latter referred to above, agrees with the investigating agent's inventory. It later appears (October 30th, 1944) that these effects belong to-

File 4985 - HIRSHI MERRILL. This evanee declared only effects left at the Atlas Cannery House, but nothing of value was found there by the investigating agent on July 10th, 1942. On March 1st, 1943, a release was received calling for shipment of effects from 33 Chatham Street. The Security Commission asked for no action pending guarantee of charges, and nothing further was heard from them. In October, 1943, H.M. wrote again and at that time, Nov. 4, 1943, we wrote to J.T. for confirmation that the contents of this house did belong to H.M. This was not acknowledged until October 30, 1944, when J.T. confirmed correctness of H.M.'s claim.

File 14826 - Mrs. Yumi MATSUI. Finally it has now come to light that this lady declared some effects left here though it was almost impossible to identify these on the inventor, referred to above.

Under all these circumstances the chattels actually left here may be taken to be as per the investigating agent's list given on file 4120 as later acknowledged by Mr. Hubert, but exact ownership is difficult to attribute. A copy is attached for easy reference.

The report of the above is that the only items found against an out employee under the last three headings. On the basis of being requested to check further on the two items shown as sold by neighbors, and remove them to another, in order only of 2.25. Consequently it was with the fact that it might be sent to our former Government representative for his comment. It would appear that that for some reason or other these efforts were not made to identify and were subsequently stated.

It is interesting to note that Mrs. Robert's letter of January 1947, states as follows:

When 33 Madison Street was sold, our Government agent was requested on November 4, 1947, to view the contents. He reported on November 22nd that Mrs. Robert claimed that she sent out of town some time ago and had arranged with our former Government representative to remove some of the contents, at which time another item was sold. Our former Government representative does not recall this transaction or the sale of some effects as stated by Mrs. Robert. It is possible only a few items could be found and there are shown as "sold to another" on our evidence. The other items are shown as sold by neighbors and a few others as "abandoned as follows."

Would you be good enough please to refer to Files 4120 and 14828 and take note of my letter dated January 6th addressed to J. M. Robertson, Insurance Adjuster, to which I attached a list of chattels that were said to be stored on the premises at the time of the fire. This list was made up of furniture and personal effects belonging to Jiroichi TANAKA, File 4120, and the last 7 items belonging to Yasu HATTORI, File 14828.

Mr. Robertson endeavoured to check this matter with Arthur Hubert and wrote to him January 8th. The information received from Mr. Hubert, through Mr. Harris in answer to this letter, indicated that he did not know much about it and took for granted apparently that excepting for the articles moved from the premises by the Custodian, that the other chattels must have been in the house at the time of the fire.

J. M. Robertson Company has now received a letter from Mrs. A. H. Hubert, copy of which you will find on file and which in effect, states that there was nothing in the house belonging to the Japanese. In view of this information from Mrs. Hubert, which seems quite definite, we cannot pursue this claim further.

Dear Sir:-

All the things that were listed were in the house until two years ago when the Japanese wanted them sent to them. At that time Mr. Robinson came to the house and told me to have them ready as he would send a truck for them. My husband was away at the time so I had a neighbor help me put the heaviest things out in the shed. That was before Easter, and on the holidays we went over to Nanaimo and did not return until August. Our neighbors in the meantime went to Mr. Robinson and told him that the things were in the shed but still nothing was done about taking the things so some of the neighbors were told if they wanted to buy any of the things they could. When we came back all that was left was a few old bedsteads and there was a box that had been nailed up that some children had broken into so I burned it as it was Japanese things made of thin wood and good for nothing that I could see.

Before Xmas another man came with this same list. He took the stove that was in the shed and a few other things, chairs, and the only thing that they left was a homemade kitchen table and a long bench. I wanted to buy these things but was told that they'd leave them but would have to take them also as they were to be sold at the Auction.

The Bureau you have in brackets was out in the shed but the children broke the mirror.

In your other letter you mentioned about a secret hiding place. I don't know of any. That's all I think. The only thing I'm sorry for is that we did not have our things insured.

Could you tell us what started the fire?
