The above, who made his declaration to the Custodian on July 29th, 1942, and was evacuated on Nov. 3, 1942, declared chattels as listed on Chattel Schedule. These were left at 26 Moncton St., Steveston, which store was owned and occupied by Yoshio NISHI, Int. 1033. Chattels were moved from this property by the agent of the Custodian on Oct. 29, 1942, to the Japanese Church Storage, List #75, all in the name of the owner of the place, Yoshio NISHI. It is impossible at this time to identify the chattels of the above as none were found tagged with his name.

When our agent entered this house on Oct. 29/42, he reported that the place had been broken into and badly ransacked. The property had been boarded up by the owner who stated in a letter dated Sept. 29, 1942, from the Dept. of National Defence, Internment Camp, Angler, Ont., that the building contained not only his own effects but also some personal effects of his friends. So far we have found the following files whose J.P. forms declare chattels at this address:

In due course the internee, Yoshio NISHI, will be sent a list of goods removed from his property at 26 Moncton St. and be asked to identify the items which belong to the above mentioned persons.
