Recently we were advised by your office that a Dominion Government cheque in redemption of War Savings Certificates was forwarded to the above c/o the R. C. M. P., Merritt, B. C. Originally the War Savings Certificates were given to us by Mr. Suzuki to apply on his account, and on July 10th, 1943 we handed same to the Bank of Montreal, Main and Hastings Branch, in order that we might obtain the funds therefore. However, the cheque was sent to your office from Ottawa, direct, and we were unable to arrange to obtain settlement.

We have written to the Merritt Detachment of the R. C. M. P., who advise that as at August 10th they have not received a cheque for distribution to Suzuki.

Would you be kind enough to check into this matter, and endeavor to trace the disposition of this cheque?
