With reference to your letter of the 8th instant and ours of the 12th, we are advised by P. S. Ross & Sons, who are handling the affairs of the Japan & Canada Trust Savings Company, that they have checked up your account and find that the last entry was June 2, 1942, when there was a balance of \$2.56, which was transferred to the Bank of Montreal, East End Branch, Vancouver---thus you have had no funds in the above Savings Company since the above date.
