On August 24th. we wrote to you telling you that we had your husband's registration forms in which he declared "real" and "personal property" and we asked you, if you had no property remaining in the Protected Area except that already registered by your husband, to fill up, sign and return to us the yellow "No Property" Declaration card but we have not yet received any answer from you.

As we think this may mean that you have some property in the Protected Area, besides that which your husband registered we now enclose 'JP' Property Declaration Forms.

Please fill up, sign and return to us either the card or two copies of the form.
