Life Insurance: This Japanese person declared a Crown Life Insurance policy for \$1000.00, paid up for 3 years, in the name of his daughter, Kasuko. In January 1946 we received a letter from the Crown Life advising that the Japanese had requested the cash surrender value of this policy. We instructed them to forward the amount in question, namely \$58.72, direct to the Japanese and send a copy of their letter to us. This was done as per copy of their letter on file dated January 23, 1946.
