

Under date of February 11, 1946 an amount of \$4.23 was credited to this Evacuee's account, previously incorrectly credited to his mother's account No. 7163. This represents refund of security deposit for Light from the B. C. Electric Company.

Life Insurance:

This Japanese person declared a Crown Life Insurance policy for \$1000.00, paid up for 3 years, in the name of his daughter, Kazuko. In January 1946 we received a letter from the Crown Life advising that the Japanese had requested the cash surrender value of this policy. We instructed them to forward the amount in question, namely \$58.72, direct to the Japanese and send a copy of their letter to us. This was done as per copy of their letter on file dated January 23, 1946.
