Spain, Protection Department. GBS/HMS Mr. Vybral called on November 10th and said that he was not notified by Mr. Oye of his evacuation. Mr. Oye owed him two months rent when he left and this is still outstanding. Water Bill also not paid. He found the premises empty and already entered and ransacked by neighbours.
