It is possible that Mr. ONOUYE had an interest in this boat and this is the boat referred to by the R. C. M. P. Our vessel records show that this boat was sold by the registered owner and that the net proceeds of \$1,460.20 were paid to Saichi TAMOTO on April 11, 1942 on authority of Usuke SHISHIKURA.
