GENERAL SUMMARY

May 29, 1946.

Re: Yoshio MATSUDA, Reg. No. 09425

This man did not sign a declaration to the Custodian until December 27, 1943. He was evacuated on March 19, 1942.

In his declaration he reported tools stored with the Pacific Shingle Co., Indian River, B.C. As 21 months had elapsed nothing was done about these tools.

In his declaration he reported a bank account with the Canadian Bank of Commerce, New Westminster, and a bank account with the Royal Bank of Canada, Vancouver. These did not come under the control of the Custodian.
