

The above Japanese National from Ocean Falls, B. C., did not register with the Custodian.



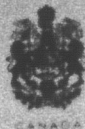
We also wish to report on Kazuo TAKAIATSU, who returned to Japan on October 2nd, 1946. The information is the same as given to you above.
