MEMORANDUM

The 18 "Judo" mats appraised by Auctioneer Ross and sold to the National Ukrainian Federation for \$18.00 belong to Rainsuke Kinoshita, Reg. No. 02493, File 1846, according to a letter received from Yoshikazu Nishimura, President of Nampa Young Buddhists' Association. This information appears to be in accordance with the list of household goods supplied by Kinoshita at the time of his evacuation. The item appears as Japanese straw mattress (20).

We are accordingly transferring the sum of \$18.00 from the account of Nampa Buddhists' Association, File 15711, to Suspense Account for final transfer to Kinoshita's account when this file is reviewed.
