EVACUATION SECTION

We have received an enquiry from your Mrs. McArthur regarding the ownership of property and equipment previously in the hands of the Vancouver Japanese Welfare Association.

Over a period of years from 1934 to 1942 this Association had been in receipt of funds to the extent of approximately \$10,000.00 from the Vancouver Welfare Federation (now the Community Chest of Greater Vancouver). These funds were used for the conduct of welfare work among the Japanese community and the operation of a T B Clinic in co-operation with the City Realth Department.

We feel, therefore, that this equipment should be used for general welfare work in Vancouver and as the bodies engaged in this work are numbers of the Community Chest and Welfare Council of Greater Tencouver, it would seem logical that these assets should be handed to us and their disposition left to our discretion with the assurance that they will thus be put to the use for which they were originally provided.
