
Dear Sirs:

In reply to your letter of the 11th ultimo, we wish to advise that the refund of over-payment of Income Tax, in the amount of \$15.11, was received by us and credited to your account on February 20th, 1947. This amount was turned over to the Dominion of Canada Treasury Office for remittance to you on May 21st, 1947.

With regard to your Refundable Savings Portion of Income Tax, we have today received a cheque from the Dominion Government for \$26.16, which is the refund from your 1942 Income Tax, of \$24.00, plus interest of \$2.16. This amount, in turn, will be turned over to the Treasury Office for remittance to you.

We have no other receipts of Refundable Savings Portion in your name, and if you could tell us in what years the other amounts are due, we can then apply to the Government for these refunds in the years when they are payable.
